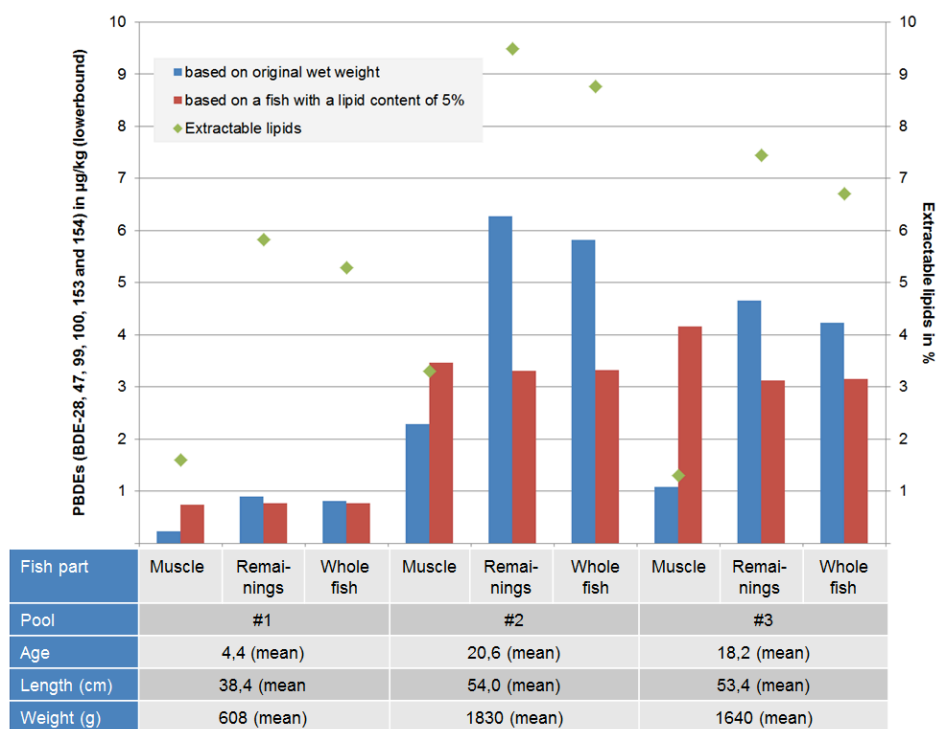


Figure 4: PBDEs in bream – Comparison between different parts of the fish



Figure 4 shows the results of PBDEs in muscle, the remaining part of the fish as well as the levels received by calculation for the whole fish in three different pools of different fish age / size. A normalisation of the analytical results to a general lipid content of 5% could help to overcome differences when analysing muscle only or the whole fish. But the choice of the fish species to be monitored as well as the age / size of the fish will need attentive consideration.
